Superintendent's Current Employment Contract

Merle Stan Simonson is the Superintendent of St. Mary's Charter School. He does not have a formal contract with the Board of Directors. However, his yearly salary for the 2018-2019 school year is \$82,164. His benefit package includes \$30,000 worth of life insurance for which the school contributes \$18.72. Contributions amounts are yearly.
