Superintendent's Current Employment Contract

Merle Stan Simonson is the Superintendent of St. Mary's Charter School. He does not have a formal contract with the Board of Directors. However, his yearly salary for the 2019-2020 school year is \$92,164. His benefit package includes \$30,000 worth of life insurance for which the school contributes \$17.28. Contribution amounts are yearly.
