2020-2021: Using data based on the 2019-2020 school year, the charter school received a "Yes" to indicators 1-5, a score of "10" for indicators 7, 8, 10-12, and 15, a "6" for indicator 14, and a "5" for indicators 9, 13, 16, and 20 for a total score of 96 giving the charter school an "A - Superior" rating.

2019-2020: Using data based on the 2018-2019 school year, the charter school received a "Yes" to indicators 1-5 and a score of "10" for indicators 6-15 for a total score of 100 giving the charter school an "**A - Superior**" rating.

Superintendent's Current Employment Contract

Merle Stan Simonson is the Superintendent of St. Mary's Charter School. He does not have a formal contract with the Board of Directors. However, his yearly salary for the 2021-2022 school year is \$97,764. His benefit package includes \$50,000 worth of life insurance for which the school contributes \$31.20. Contribution amounts are yearly.
